## So you want to be a Lawyer?

The journey to become a lawyer requires grit, enthusiasm and energy, but the rewards can be great.

# LAW

## Solicitor | Very Strong Job Growth

Solicitors work with clients to prepare documents and information as part of a court case, or provide clients with documentation and advice in their legal matters.

You could start as a Junior Solicitor, then progress to become a Senior Solicitor or General/Legal Counsel.

## Barrister | Very Strong Job Growth

Barristers usually act as advocates for clients in a courtroom setting. They offer specialist advice and work with Solicitors to serve clients.

You could start as a Junior Counsel, then become a Queen's/Senior Counsel or a Judge or Magistrate.

"Lawyer" is a term that encompasses many different kinds of legal professionals, including solicitors, barristers, mediators and judges.

# THE LAW PROFESSION

For millennia, people have lived together peacefully thanks to rules and law. Law has a long-stretching history in civilisations across the world.

In Australia, our legal system is based on the system brought over from the UK during colonisation, and still shares many similarities with it today.

Australia has a robust legal system with opportunities for careers in several different areas of law.

You could become a solicitor and practice law in a firm or business, advising clients on a variety of legal matters, or a barrister and represent clients in the courtroom.



As society evolves, the law does too. Some recent significant legal changes include native title and same-sex marriage, and even now with COVID-19, we are seeing the evolution of the legal system as courts move online.

As a lawyer, you could expect to find yourself:

- listening to client's problems
- providing legal advice
- discussing their options
- taking instructions about what they want to do
- helping them to understand how the law applies to their case
- explaining the limitations of the law
- representing clients in court

You'll be required to complete mandatory continuing professional development each year to maintain your practising certificate (varies between states).

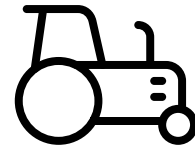

As a Lawyer, you could find yourself working in a private practice, in-house or in a government role.

Generally, there is high demand for Lawyers across all states, but the demand is highest in New South Wales.

In remote and regional areas there is a high demand for Lawyers, as many communities don't have access to legal practitioners. If you're considering a career in law you could find applications for roles in these locations less competitive.

Remote and regional areas generally don't have many specialist lawyers, so your chance of exposure to many varied issues is far greater.

Law is a highly competitive industry to get into.

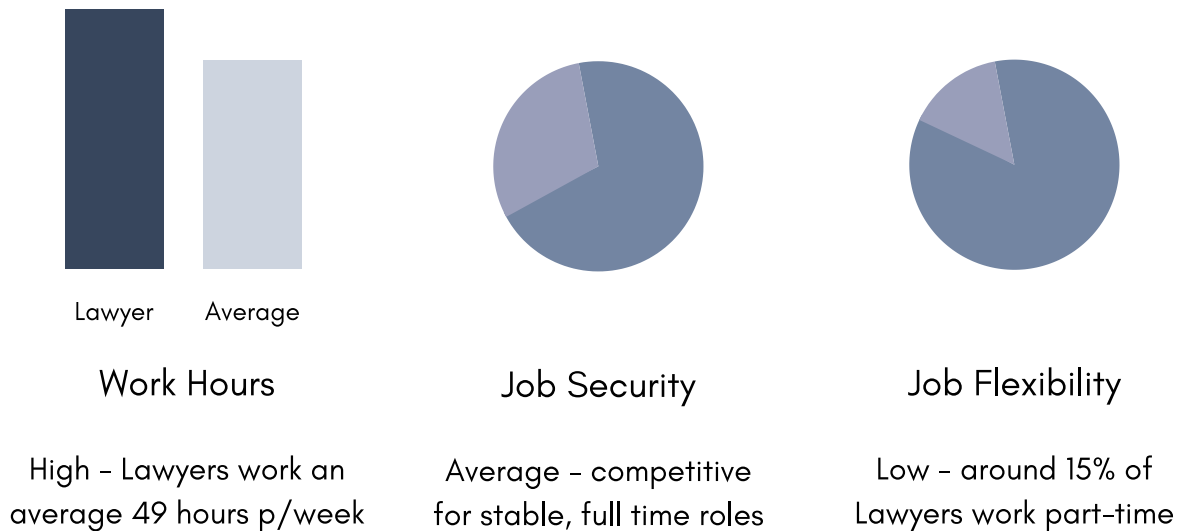
Once you have graduated and registered, you may consider applying for internships and even voluntary roles in order to gain experience and do some valuable networking.

Admission to practise in law is regulated by the states so you'll need to check the requirements.

Once you've been admitted, individual employers can determine your working conditions and you'll be free to negotiate salary and conditions.

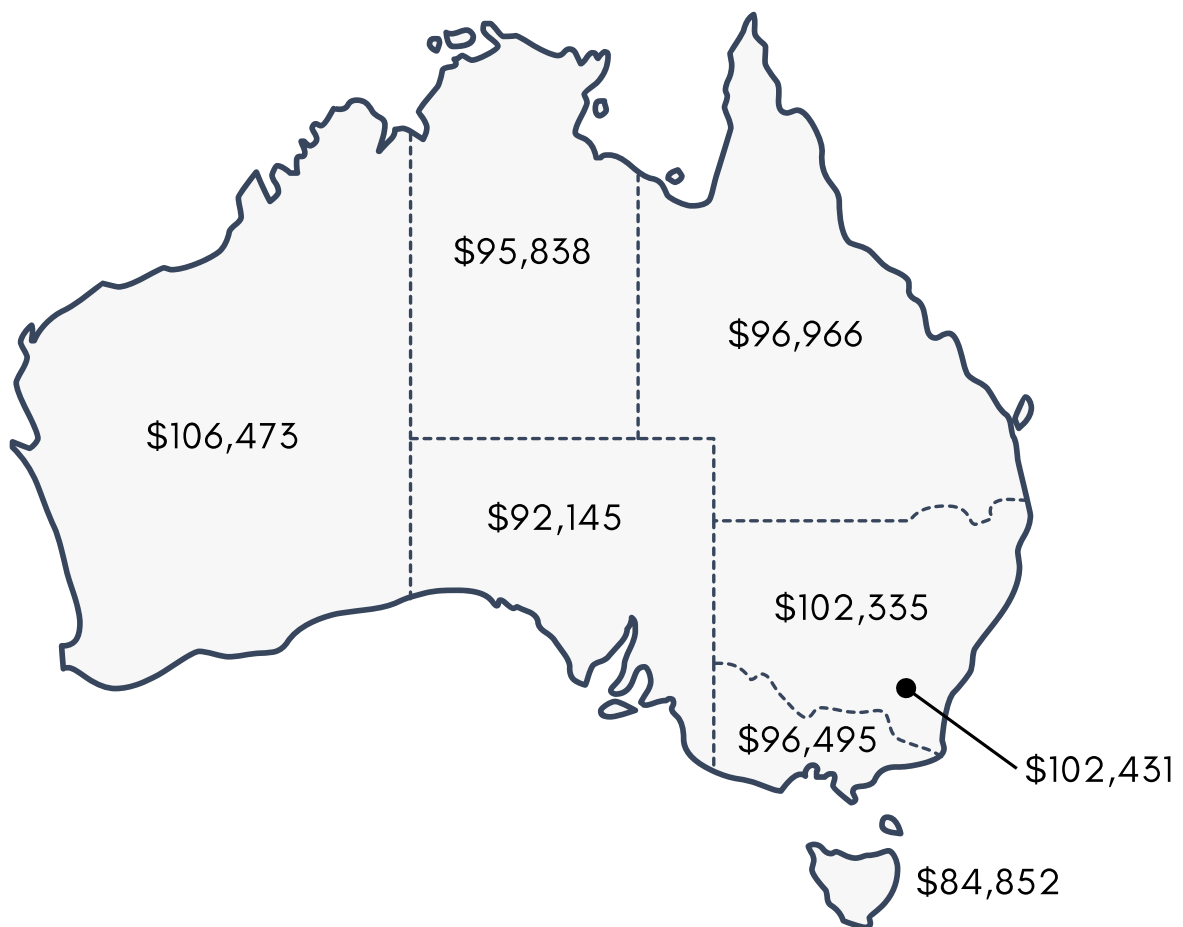

Law graduates make an average of \$63,200 in their first year, and have a high earning capacity over their lifetime. Lawyers have the potential to earn far higher than average salaries.

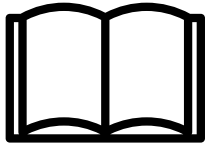
The average salary of a lawyer by state:

## **Active or Reflective**

Active people like to jump right into the task at hand, but reflective people like to think things through first.

Lawyers often spend time researching and informing themselves in advance, but when working with clients or in the courtroom unexpected events and changes happen. If you're the kind of person who likes to take their time making decisions, you could find yourself under pressure.

## **Sensing or Intuitive**

Sensing people like to follow the plan and stick to facts, and thrive in a predictable environment. Legal situations can be unpredictable, but your patience, listening and mediation skills could help you to remain in control of proceedings.

Intuitive people like to innovate and try things out, and can get bored doing the same job twice. Lawyers will often have many repetitive jobs and tasks which could be challenging if you like to change things up. You could consider becoming a Barrister, as life in the court room could be a better fit.

## **Visual or Verbal**

Writing contracts, researching and arguing cases, negotiating deals and agreements all require excellent communication skills, meaning verbal learners could thrive as a lawyer.

Visual learners may struggle more with some aspects of law but they tend to be great problem solvers with great listening and observational skills.

## **Sequential or Global**

Sequential people like to follow steps one at a time, which can be good when you're getting through cases, but global people can see the bigger picture. If you're a sequential person (and most of us are to some degree), you will excel in working out the smaller details of a case.

Global people can sometimes struggle with the details, so if you're going to become a lawyer you'll need to be comfortable slowing down and going through the steps when your clients need you to.

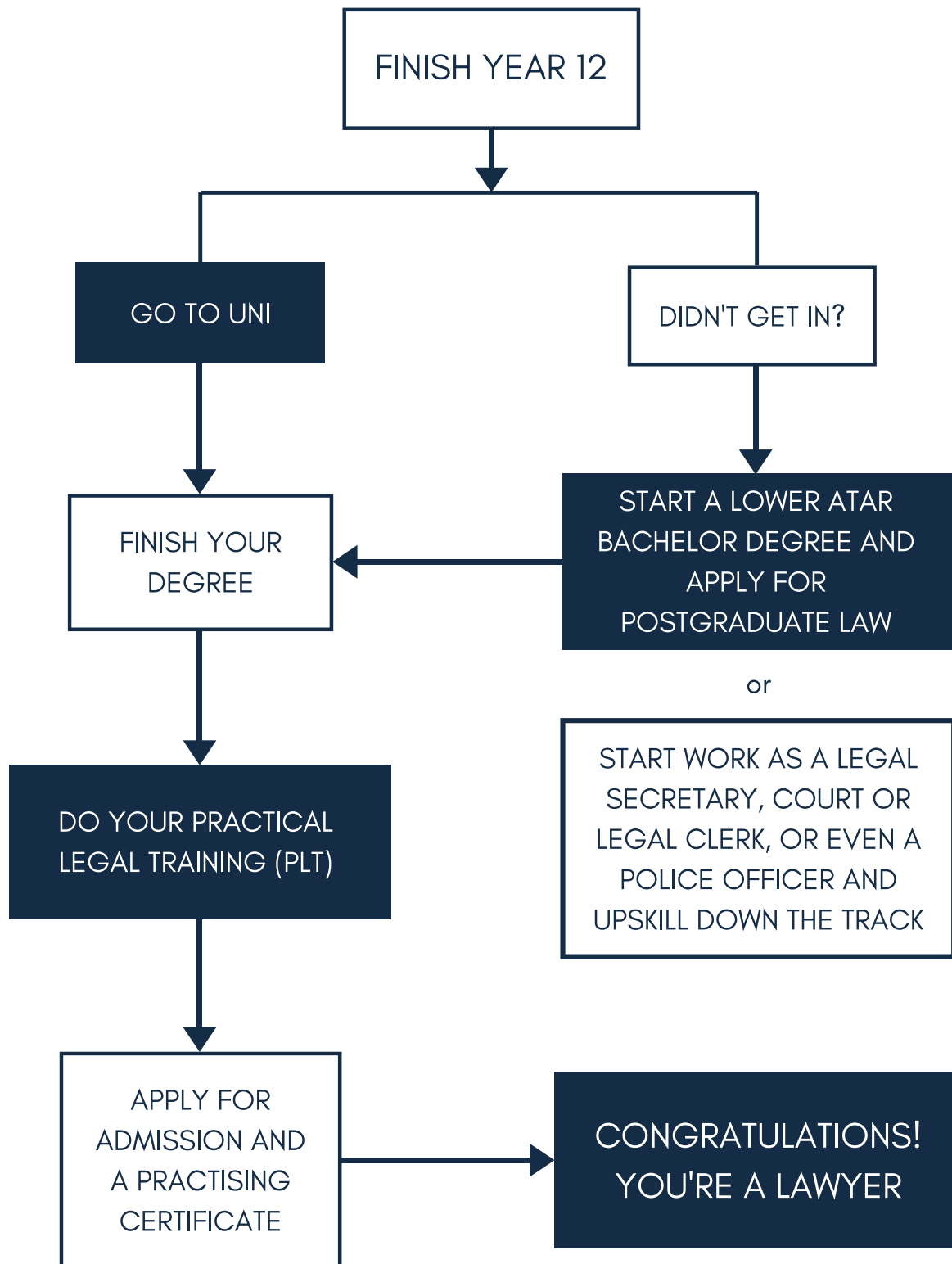

# YOUR STUDY OPTIONS

In Australia, the law degree you complete must be accredited by your State or Territory's Legal Profession Admission Board for you to be eligible to practice law once you finish.

Accredited courses cover the "Priestley 11" subjects, which give students an overview of some of the essential areas of law:

- Administrative Law
- Civil Dispute Resolution
- Company Law
- Contracts
- Criminal Law and Procedure
- Equity (including Trusts)
- Ethics and Professional Responsibility
- Evidence
- Federal and State Constitutional Law
- Property
- Torts

Note: Only accredited undergraduate courses are included in this guide. Combined and postgraduate entry degrees are not listed.

Before you commit to any course you should always double check your eligibility, whether the course is accredited and that the above subjects are covered in the core units.

As a Year 12 student you have options:

**The first**, most obvious, and possibly most competitive option is to commence one of the Undergraduate Bachelor degrees once you finish School. They could take 3-5 years to complete.

**Double or nothing:** consider a double or combined degree. You could graduate with two degrees in 5 years, with a broader range of knowledge and skills.

This could make you a more competitive candidate for employment, as well as opening up more career options.

**The second pathway** - complete an undergraduate degree in another field, then meet the requirements and apply for admission to a postgraduate Law degree.

You might need to sit the LSAT (Law School Admissions Test), and many programs have strict prerequisites and performance standards.

An added benefit of this pathway is that the range of legal careers is huge, and you may find something else you prefer along the way. Mediation, politics, social justice and advocacy are just some of the fields you could choose to pursue.

# BE COMPETITIVE

## Subject selection

In Year 11 and 12 choosing ATAR English (advanced or higher options preferably), English literature, History, Politics, and of course Law could help you meet the eligibility requirements for your preferred courses.

Having prior knowledge from these subjects could also help you maintain a higher GPA (Grade Point Average). That could both help you apply for postgraduate opportunities and be more appealing to employers.

## Keep your conduct and records impeccable

To be successfully admitted into Law, you'll need to be a "fit and proper person".

Your character will be scrutinised and you'll have to declare any criminal, academic or general misconduct. It's worth bearing in mind even at high school, so your future as a lawyer isn't jeopardised.



## Get relevant experience and knowledge

Find out if Law is a career for you.

Get a feel for the language and overall environment, while building on your skills and knowledge - it could make you a more appealing applicant to the university law schools, as well as to potential employers.

## Consider advanced postgraduate studies

Taking time to complete an Honours degree (usually an additional year), post-graduate certificates, or even a Masters degree (LLM), could really boost your confidence and elevate your resume to the next level.



# PRACTICAL LEGAL TRAINING

Finishing your degree is just the first step towards being able to practice as a lawyer.

After you finish your degree, you will then be required to undertake between 6 and 12 months of Practical Legal Training (PLT). The form and length of PLT can differ depending on the requirements in your state.

There are three main kinds of PLT:

- Graduate Diploma in Legal Practice
- Supervised Legal Training (in QLD and VIC)
- Clerkship (WA) or other traineeship

## Graduate Diploma in Legal Practice

A Graduate Diploma in Legal Practice (GDLP) is usually a 6 to 12 month course that combines coursework with practical work placements.

To apply for most GDLPs, you'll need to have finished your undergraduate degree first. Occasionally you can commence your GDLPs before graduating. You'll have to check with each provider individually.

## Supervised Legal Training

Supervised Legal Training (SLT) is a 12-month traineeship with a legal practitioner. Instead of continuing studies, you will receive training from a mentor. You'll be classed as an employee of a firm and get paid. This kind of training is only available in Victoria and Queensland.

## Articles of Clerkship

Similar to SLT, your work placement under a supervisor conforms to set standards. Only around 50 applications a year are received for this method of PLT in WA, so it's becoming increasingly uncommon.

## Judges' Associate

The Federal Court of Australia, Family Court of Australia and the Federal Circuit Court of Australia offer a few places annually to recent law graduates to work as a Judges' Associate.

These positions are prestigious and competitive, and only a few are offered each year (and are not an option in all states).

# ADMISSIONS PROCESS

There are some differences in the admission process between states, but the main process is the same across Australia.

Firstly, you must send in your application to the relevant body (such as the Legal Profession Admission Board in New South Wales, or your state or territory's Supreme Court). They will ensure that you have completed the relevant study and training to be admitted, and may also require references.

This is where they will assess whether you are "fit to practice" law. They may look at things like your student record (including any academic misconduct), criminal history, driving record, or whether you have any outstanding debts.

You must disclose anything that may affect your application. Note, however, that having any negative history does not necessarily mean you can never be admitted to practice.

If your application is successful, you will then be invited to attend an admission ceremony, which is usually held in your state or territory's Supreme Court. Your admission will be "moved" by someone who is currently admitted for practice, and you will then be asked to take an oath.

After the ceremony, you will sign the Supreme Court Role, and are now officially a lawyer.

# NEW SOUTH WALES

Apply to the Legal Profession Admission Board for a compliance certificate.

To apply you must:

- be aged 18 years or over; and
- not be already admitted to the Australian legal profession; and
- have attained the specified academic qualifications prerequisite; and
- have satisfactorily completed the specified practical legal training prerequisite; and
- be a fit and proper person to be admitted to the Australian legal profession

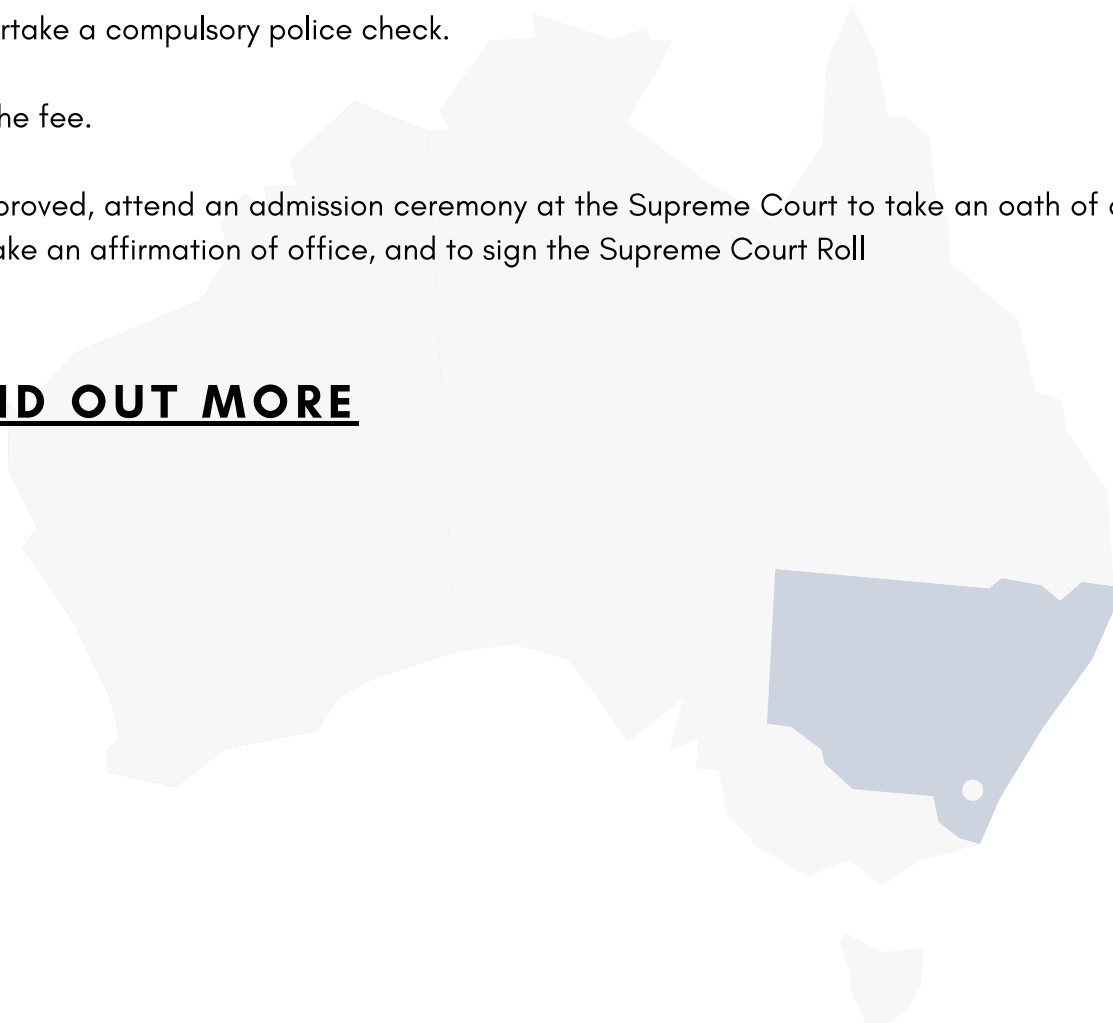
You'll need to submit a completed application and all the required documentation and evidence including evidence of your qualification, PLT, your personal statement and two character references.

Undertake a compulsory police check.

Pay the fee.

If approved, attend an admission ceremony at the Supreme Court to take an oath of office or make an affirmation of office, and to sign the Supreme Court Roll

# Admissions in **VICTORIA**

File an application with the Victorian Legal Admissions Board.

To apply you must:

- Be aged 18 years or over
- Not already be admitted to the Australian legal profession
- Have attained the specified academic qualifications prerequisite
- Have satisfactorily completed the specified practical legal training prerequisite
- Be a fit and proper person to be admitted to the Australian legal profession

You must also lodge a completed Application for Compliance Certificate form including:

- Academic transcript
- Student Conduct Report from your uni and PLT provider
- A National Police Certificate
- Two character statements
- A disclosure statement and capacity disclosure statutory declaration if required
- Photo ID

Pay your fees.

If approved, you'll need to take an oath of office, or make an affirmation of office, in the form required by the Supreme Court.

# Admissions in **QUEENSLAND**

Apply to the Legal Practitioners Admissions Board.

To apply you must:

- Have complete approved law qualifications
- Have undertaken approved practical legal training via a practical legal training course or Supervised Traineeship at a firm
- Be able to satisfy the Admissions Board and the Court of their fitness to practise

Submit your completed application and any required supporting documentation or evidence.

Pay the fee.

If approved, you'll need to attend an admission ceremony at the Court of Appeal in Brisbane or at a Supreme Court in regional areas and carry out an oath or affirmation of allegiance. You'll then be admitted to the Roll of Lawyers.

Before you can start practising, you'll also need to apply for a practising certificate.

# AUSTRALIAN CAPITAL TERRITORY

File an originating application for admission to law with the ACT Supreme Court. You must file your application at least 21 days before the admission day. You'll need to file your application in person if you live in the ACT.

Include any relevant supporting documentation or evidence with your application, such as:

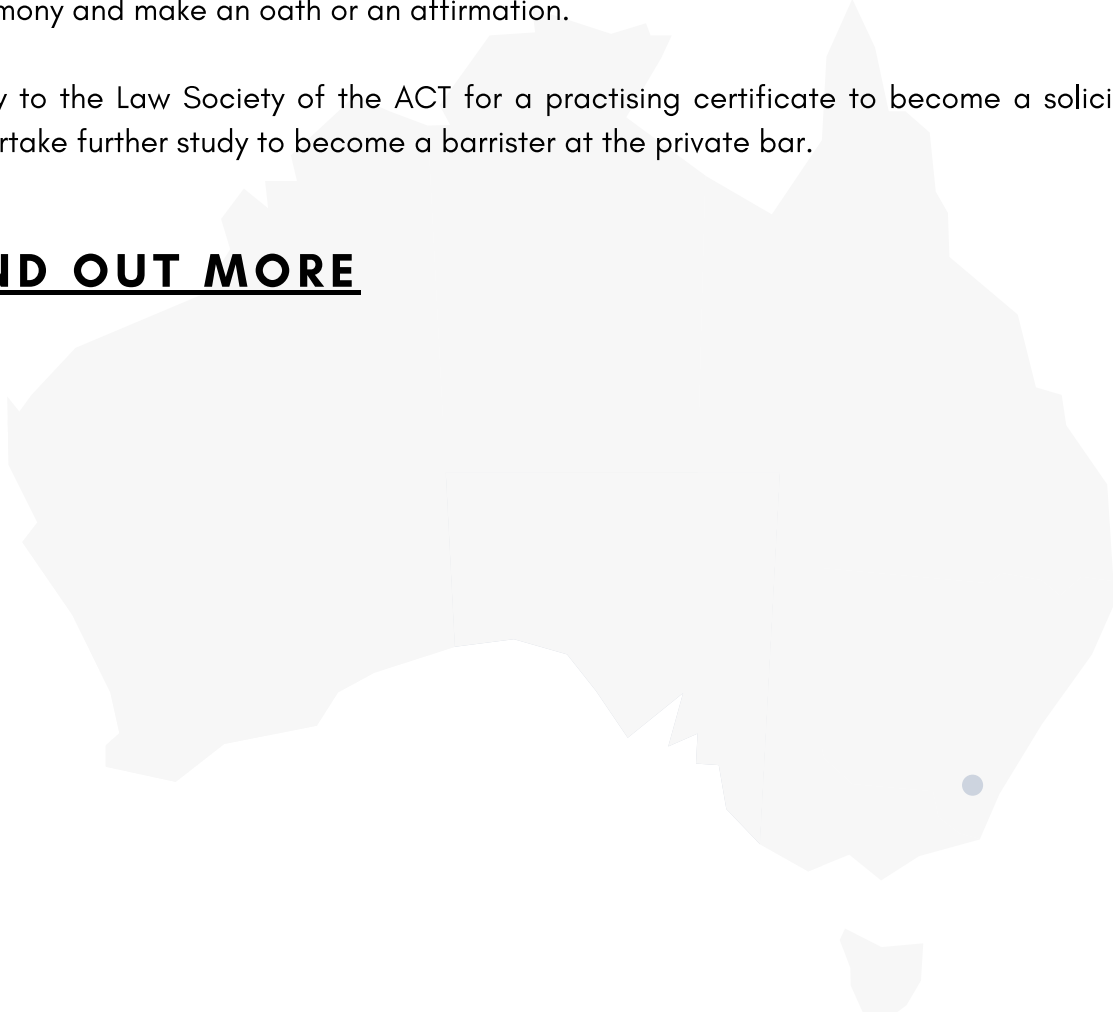
- A personal affidavit including full disclosure
- Three character affidavits

Pay the fee

If your application is approved, you'll need to attend a ceremony, agree to the terms of the ceremony and make an oath or an affirmation.

Apply to the Law Society of the ACT for a practising certificate to become a solicitor or undertake further study to become a barrister at the private bar.

# **SOUTH AUSTRALIA**

File an originating application with the Law Society of South Australia.

To apply you must:

- Have completed an approved academic qualification
- Have completed the required PLT
- Be of fit and proper character

Provide any required documentation when you submit your completed application to the Board of Examiners for its report and recommendation. This may include an affidavit or statutory declaration.

Pay the fee.

If the report recommends admission, the Supreme Court will list your application for hearing, which you must attend in person.

If you are approved, you'll sign the Roll of Practitioners and become a Barrister or Solicitor of the Supreme Court of South Australia.

You'll then need to apply to the society for a practising certificate before you can start working in legal practice.

# WESTERN AUSTRALIA

Apply through the Legal Practising Board of Western Australia.

To apply you must:

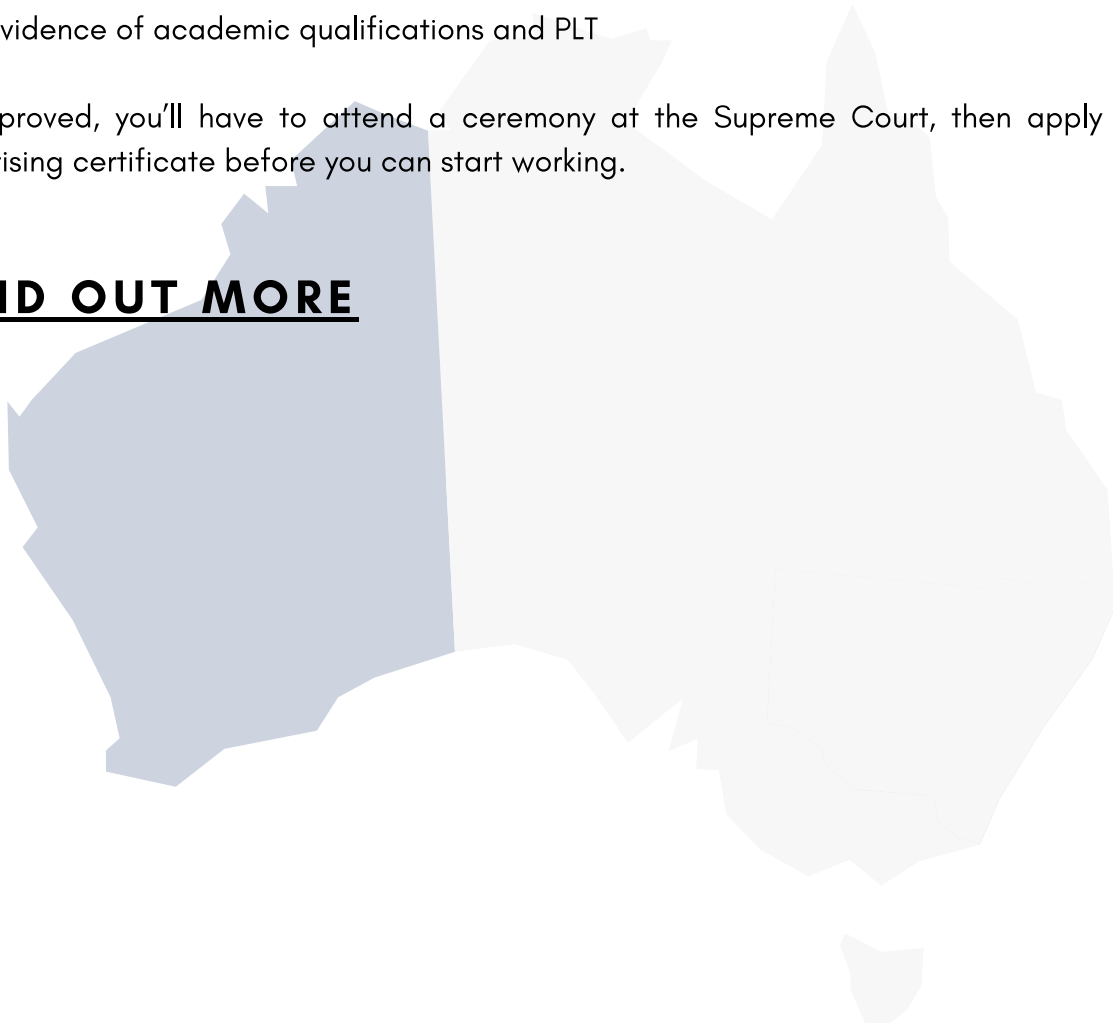
- Have completed academic requirements
- Have completed the PLT requirements
- Be a fit and proper person
- Satisfy English Language Proficiency Requirements

File a Motion Paper with the Supreme Court at least 2 months before your proposed admission date. Within 2 days of filing your Motion Paper you must also file a Notice of Application for Admission, including supporting documents such as:

- Police Certificate
- Evidence of academic qualifications and PLT

If approved, you'll have to attend a ceremony at the Supreme Court, then apply for a practising certificate before you can start working.

# NORTHERN TERRITORY

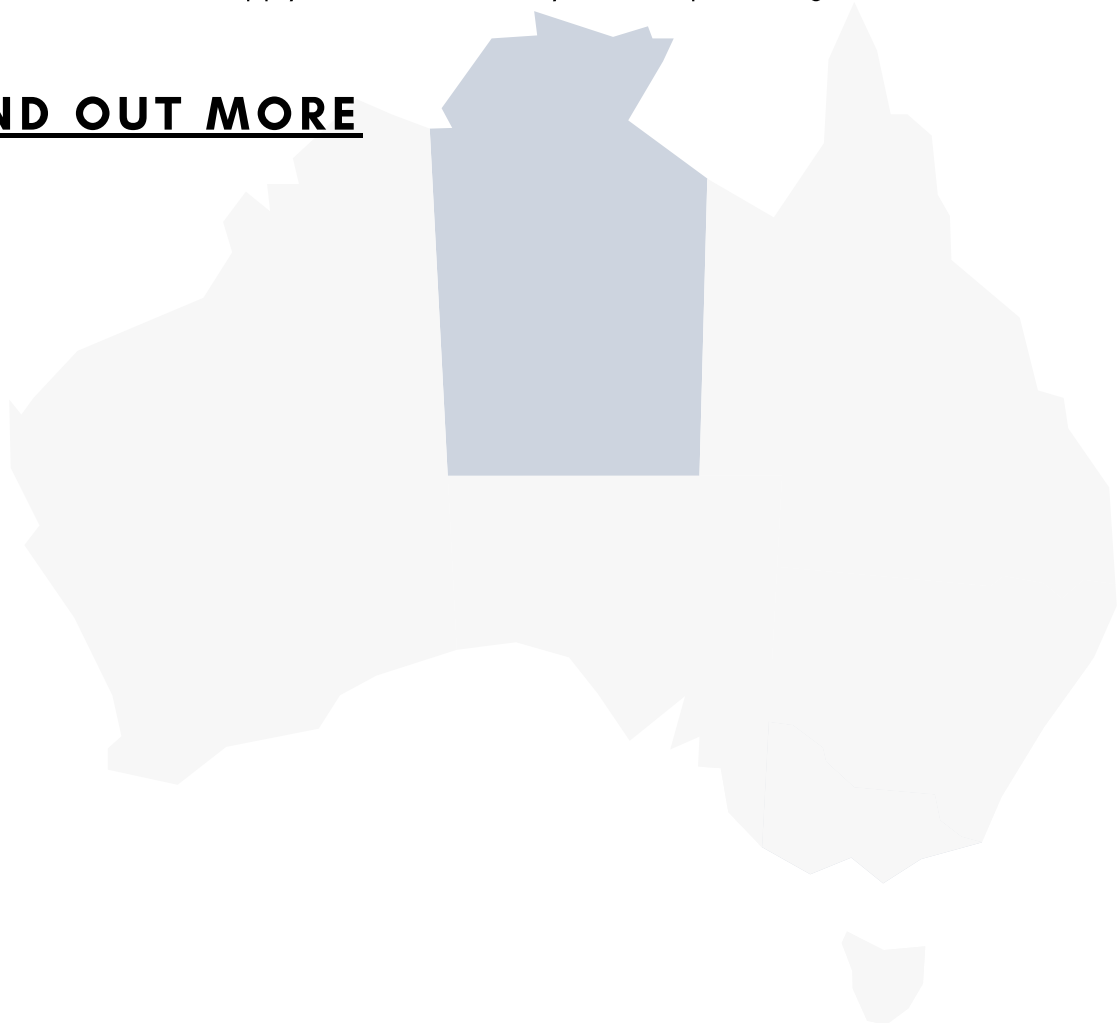
Apply through Legal Practitioners Admission Board for admission to the Supreme Court.

You must be eligible (completed required approved academic qualifications and approved PLT) and suitable for admission. You must provide the following along with your completed application:

- Academic certification
- PLT certification
- A personal full disclosure affidavit to determine your suitability
- English proficiency
- A National criminal history check through SAFE NT
- Two character references

You will also need to apply to the Law Society NT for a practising certificate.

# Admissions in **TASMANIA**

Apply to the Supreme Court of Tasmania for admission to the legal profession.

To apply you must:

- Have appropriate academic qualifications
- Have appropriate practical legal training
- Have proof you are a fit and proper person for admission

You'll need to submit a completed application with all the appropriate supporting documentation and evidence, such as a full disclosure statement about your suitability for admission, character statements, etc.

Pay any fees.

If you are approved, you'll need to attend a ceremony at the Supreme Court and sign the Roll of Practitioners.

You'll then need to apply to the Law Society of Tasmania for a practising certificate.

# CREATING A PLAN B

So, you may want to consider something other than Legal Studies if there's something else you're interested in.

Luckily, many Graduate Law Programs (i.e. ones you can only get into once you already have a degree) don't put limits on the type of degree you can have. Which means that you could apply with a Bachelor of Arts, Nursing, Engineering, Accounting, or IT.

It could be wise for your Plan B to include career options other than 'lawyer', in case you don't get into an accredited law course, or you change your mind during your uni studies.

It's a great idea to have a Plan B for which course or pathway you'll take if you don't get an offer for your first preference.

You can still achieve your goal of a career in law if you miss out in the first round of offers, so don't give up.

Research alternative pathways with each uni, and look around at all the degrees on offer. They'll have different eligibility criteria, e.g. lower ATAR requirements.

A Bachelor of Legal Studies is one alternative to Law. It's also a competitive pathway, as other highly talented students who also just missed out on law often apply. Bear in mind this could make it harder to get a good GPA, which in turn could make it more challenging to get into a Graduate Law Program.
